Mandatory Technical qualifications for participating

- The vendor must have valid current empanelment with Indian Bank (our sponsor bank) approved suppliers of security equipment such as firefighting systems, fire alarms and fire extinguishers, copies to be enclosed.

- Bank has the right to negotiate / fix the rate with L-1 vendor.
- Tender should be with the total price inclusive of base rate and GST as per Annexure II.
- The L-1 would normally be arrived based on the overall price (Grand Total) quoted by the vendor. However, in the event of bank choosing to go for specific item/s, bank would choose to select the items to be supplied / installed. So, Vendor's price would include individual items as well as total price also.
- Vendors should have valid GST Registration No. & it should be clearly mentioned in the Price Quote.
- The selected vendor is required to Supply and Install the Fire Fighting System at our Head office new administrative building at Chittoor as per our requirement.

- Vendor quote should include all costs, including logistics. No transportation charges for delivery and installation will be paid.
- Supply and Installation of the Fire Fighting System should be done within 60 days from the date of Work Order (WO). If not completed within 60 days from the date of WO, Bank has right to cancel the order without prior notice and bank will not bear any expenses.
- In case of non-fulfillment of desired quality as per specifications, Bank has right to cancel the order without prior notice and bank will not bear any expenses.
- Bank will not be responsible for any injuries / damages / death of labour occurred during transportation / installation process. Company / Vendor / Dealer have to deal with the compensation process.
- If any bank property is damaged during installation / shifting / movement of the equipment/s, those damages should be compensated by the Company / Vendor / Dealer.
- If L1 fails to supply the item(s) for any reason, the name of such vendor shall be kept under Black List
 and shall not be allowed to participate in future works of the Bank. Subsequently the order will be
 allotted to the other participant vendors, one who agrees to supply the item(s) at the rate quoted by L1
 vendor.

 as "Quotation for Supply and Installation of Fire Fighting System" and this cover should contain "two
 separate envelopes" superscripted as detailed below:

- Payment would be made only after satisfactory supply and Installation of Fire Fighting System at our Head Office new administrative building at Chittoor, i.e., No advance payment would be given and accepted rate will be paid only after completion of work.
- The last date for submission of sealed quotation is 15.04.2024, up to 03.00 pm and date & time of opening sealed quotations is 15.04.2024 at 04.00 pm at Saptagiri Grameena Bank, Head office, Chittoor.
- The sealed quotation should be dropped in box which is placed at Development Dept. Head office, Chittoor, in person.
