Smt Chintagunta Alamelu & Sri Chintagunta Balakrishna availed the above cited facility/ies from Saptagiri Grameena Bank, Raghavendra Nagar Branch, the repayment of which is secured by mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Smt Chintagunta Alamelu 1st of the above, Sri Chintagunta Balakrishna (Guarantor) 2nd of the above, and Sri Kothareddygari Nagarjuna Reddy(Guarantor) 3rd of the above failed to pay the outstanding. Therefore a Demand Notice dated 01.02.2023 under Sec 13 [2] of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 [for short called as "The Act"], was issued by the Authorised officer calling upon Smt Chintagunta Alamelu and others liable to the Bank to pay the amount due to the tune of Rs.18,66,412/- [Rupees Eighteen Lakh Sixty Six Thousand Four Hundred and Twelve only] balance as on 31.01.2023 with further interest, costs, other charges and expenses thereon. Smt Chintagunta Alamelu and others failed to make payment despite demand notice dated 01.02.2023.

As **Smt Chintagunta Alamelu and others** failed to make payment despite Demand Notice, the Authorized Officer took **possession** of the schedule mentioned properties under the Act on **24.08.2023** after complying with all legal formalities.

As per Sec.13 [4] of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the Authorized Officer intends selling the schedule mentioned securities in any of the following mode: a. By inviting tenders from public or b. By holding public auction or c. By private treaty.
