Sri G Veerabhadraiah (Prop of M/s GGS Enterprises) availed the above cited facility/ies from Saptagiri Grameena Bank, Renigunta Branch, the repayment of which is secured by mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Sri G Veerabhadraiah (Prop of M/s GGS Enterprises) and others failed to make payment despite demand notice dated 01.07.2023.

As **Sri G Veerabhadraiah** (**Prop of M/s GGS Enterprises**) and others failed to make payment despite Demand Notice, the Authorized Officer took **POSSESSION** of the schedule mentioned properties under the Act on **26.09.2023** after complying with all legal formalities.

As per Sec.13 [4] of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the Authorized Officer intends selling the schedule mentioned securities in any of the following mode: a. By inviting tenders from public or b. By holding public auction or c. By private treaty.
