## **Notice of Intended Sale**

Notice of intended sale under Rule 6 [2] and 8 [6] of the Security Interest [Enforcement Rules] 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002.

Sri P Siva & Sri P Eswar failed to make payment despite demand notice dated 22.08.2023.

As Sri P Siva & Sri P Eswar and others failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 23.11.2023 after complying with all legal formalities.

As per Sec.13 [4] of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the Authorized Officer intends selling the schedule mentioned securities in any of the following a. By inviting tenders from public or b. By holding public auction or c.
